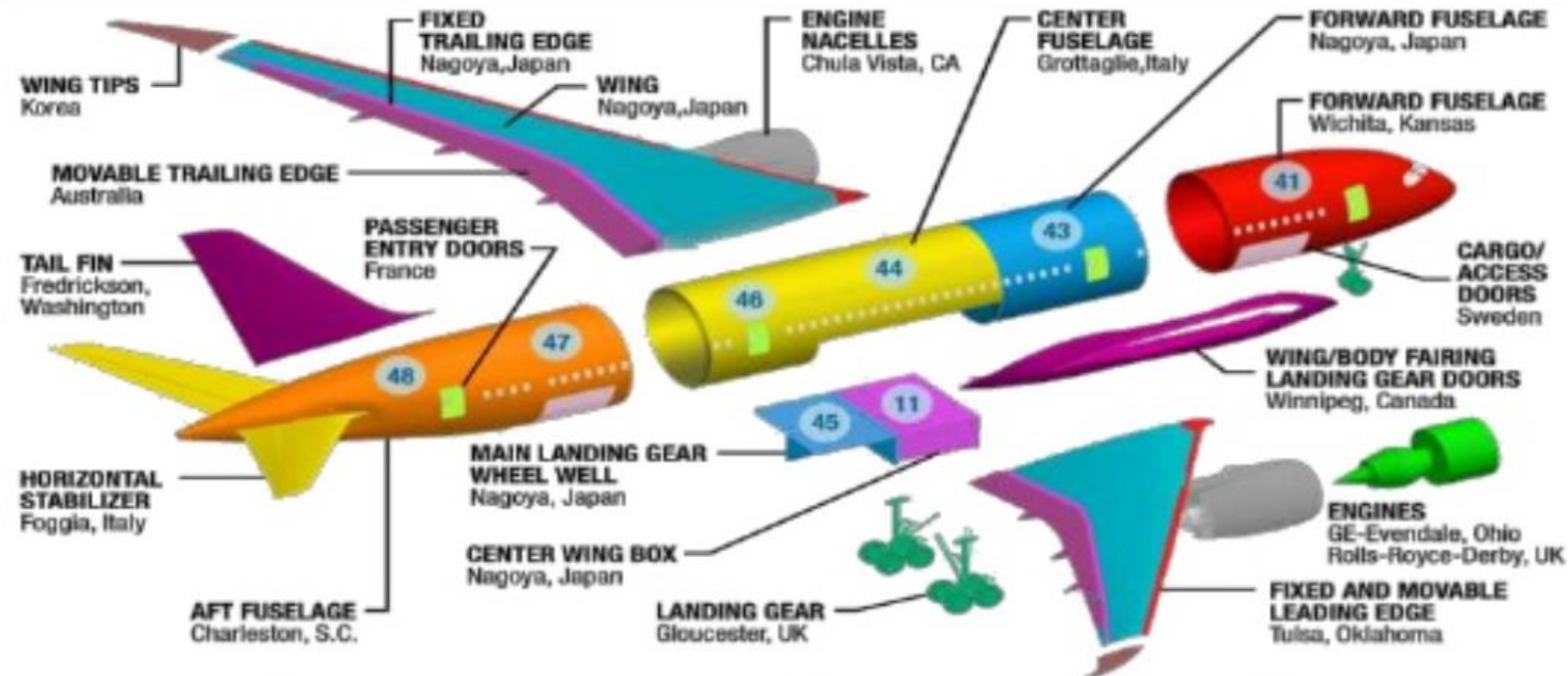

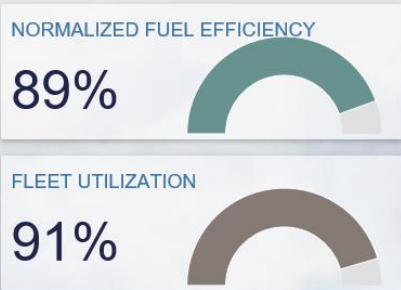




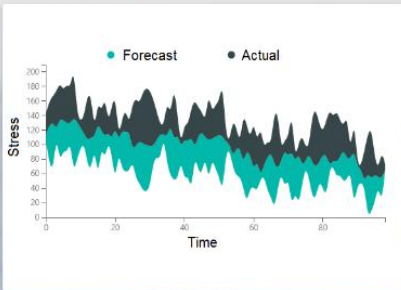
Fleet Location Map



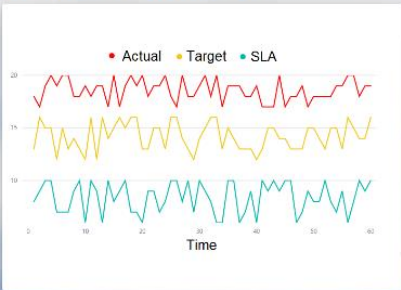

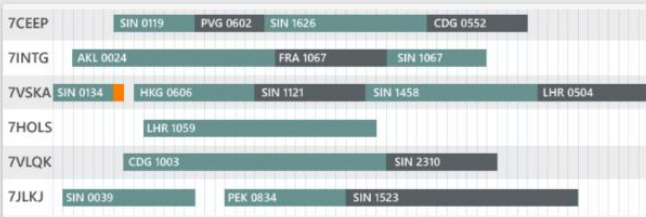
